

## LIHTC COMPLIANCE TRAINING APPROVED BY IFA

The Iowa Finance Authority's 2021 Qualified Allocation Plan does require that training be received in order to receive an 8609 as follows:

Owners and management companies of Projects shall attend a minimum of eight hours compliance training that is provided by an approved third party trainer, or by attending all sessions designated as fulfilling this requirement offered at the annual Housinglowa Conference prior to receiving the IRS Form 8609 from IFA. At the time the IRS Form 8609 Application Package is submitted, a Certificate of Compliance Training for the General Partner and property manager shall be provided. The date for the Certificate of Training shall be issued no earlier than 12 months from the time that the IRS Form 8609 Application is submitted. [Section 8.8, page 37]
