# ABOUT THE IOWA COUNCIL ON HOMELESSNESS (ICH)

The Iowa Council on Homelessness (ICH) was organized according to 2008 Iowa Acts SF 2161, which also directed the Iowa Finance Authority (IFA) to provide administrative support. Governed by Iowa Code Chapter 16.2D, the ICH is made up of representatives of state and local governments, nonprofits, advocates, and individuals with lived experience.

All 38 members of the ICH are appointed by the Governor, with 12 of those seats reserved for members representing relevant state departments, including:

- Iowa Department of Education
- Iowa Economic Development Authority
- Iowa Department of Human Services
- Iowa Department of Justice Office of the Attorney General
- Iowa Department of Human Rights
- Iowa Department of Public Health
- Iowa Department on Aging
- Iowa Department of Corrections
- Iowa Workforce Development
- Iowa Department of Public Safety
- Iowa Department of Veterans Affairs
- Iowa Finance Authority

The remaining 26 seats are comprised of members from the general public who apply for appointment through the Governor's office, with certain seats reserved for members with lived experience of homelessness and representatives of the Iowa State Association of Counties and Iowa League of Cities.

# MEMBERS AND COMMITTEES

The ICH has five official standing committees. Each standing committee has at least five voting members, elected or appointed by the ICH. Committees include:

- **Executive Committee:** Carries out the business of the ICH between regular ICH meetings.
- **Nominating Committee:** Reviews member applications, makes member recommendations to the ICH, and reviews member attendance.
- **Policy & Planning Committee:** Considers various policy issues affecting stakeholders. Provides input on the annual statewide Emergency Solutions Grant competition.
- **Public Awareness Committee:** Works to increase the public's awareness about homelessness in Iowa. Coordinates with state and local organizations on awareness events and campaigns.
- **Research and Analysis Committee:** Coordinates and conducts research on evidence based practices to prevent and end homelessness.
- **Ad Hoc Committees:** Established as needed by the ICH depending on priorities.

# STRATEGIC PLANNING BACKGROUND

Prior to 2020, the ICH served as both the state interagency council and the decision-making board for the Balance of State Continuum of Care (CoC), a federal program administered by the US Department of Housing and Urban Development (HUD). The CoC program required significant focus by the ICH to prepare competitive bids for approximately \$7 million annually in federal funding and to fulfill the program requirements.

Beginning in 2017, the ICH underwent an assessment and restructuring, resulting in the development of a new CoC Board. The ICH voted to officially separate the ICH from the new CoC entity in January 2020, enabling the ICH to redirect its focus to its other mandated duties. The ICH engaged Bronner Group, LLC in early 2021 to facilitate a strategic planning process to guide the ICH's work over the next five years. As a result of this process, the ICH determined its new mission, vision, values, and strategic goals, which are presented in this plan.

# STAKEHOLDER ENGAGEMENT PROCESS



During the research and validation phase, BRONNER and the ICH solicited feedback from a variety of stakeholders:

- Survey of ICH members (25 respondents)
- 12 ICH member and key stakeholder interviews
- 11 key stakeholder focus groups on populations and systems impacted by homelessness
- 3 interviews with national stakeholders

## Member Survey

- Members perceived lower past performance on several mandated activities related to evaluating and advising on policies, programs, statutes and rules and advising the Governor’s Office, the Iowa Finance Authority, State agencies, and private organizations on strategies to prevent and end homelessness.
- Among current members surveyed, top priorities for the future strongly favored a focus on increasing the supply of affordable housing and integrating housing and homelessness services systems.

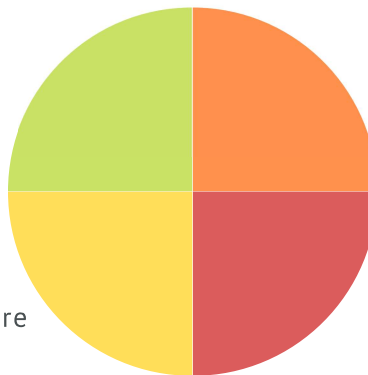

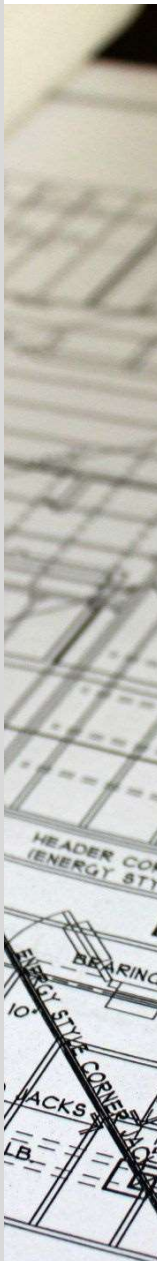

# APPENDIX

## ICH Duties (Iowa Finance Authority, §16.2D)

8. The duties of the council shall include but are not limited to the following:

a. Develop a process for evaluating state policies, programs, statutes, and rules to determine whether any state policies, programs, statutes, or rules should be revised to help prevent and alleviate homelessness.

b. Evaluate whether state agency resources could be more efficiently coordinated with other state agencies to prevent and alleviate homelessness.

c. Work to develop a coordinated and seamless service delivery system to prevent and alleviate homelessness.

d. Use existing resources to identify and prioritize efforts to prevent persons from becoming homeless and to eliminate factors that keep people homeless.

e. Identify and use federal and other funding opportunities to address and reduce homelessness within the state.

f. Work to identify causes and effects of homelessness and increase awareness among policymakers and the general public.

g. Advise the governor's office, the authority, state agencies, and private organizations on strategies to prevent and eliminate homelessness.

9. a. The council shall make annual recommendations to the governor regarding matters which impact homelessness on or before September 15.

b. The council shall prepare and file with the governor and the general assembly on or before the first day of December in each odd-numbered year, a report on homelessness in Iowa.

c. The council shall assist in the completion of the state's continuum of care application to the United States department of housing and urban development.

10. a. The authority, in consultation with the council, shall adopt rules pursuant to chapter 17A for carrying out the duties of the council pursuant to this section.

b. The council shall establish internal rules of procedure consistent with the provisions of this section.

c. Rules adopted or internal rules of procedure established pursuant to paragraph "a" or "b" shall be consistent with the requirements of the federal McKinney-Vento Homeless Assistance Act, 42 U.S.C. §11301 et seq.
