

2023 10% TEST FOR CARRYOVER ALLOCATION APPLICATION CHECKLIST

All tabs within the online Application <u>MUST</u> be updated to ensure that IFA has current information for the review of the 10% Test Application.

All Construction documents must be approved by the IFA Construction Manager prior to the approval of the 10% Test Application.

In addition to updating the online Application, the following exhibits <u>MUST</u> be uploaded to the online Application and submitted to IFA by <u>4:30</u> pm on Monday <u>July 1, 2024</u>.

- 1C* Application Certification. IFA Form Required.
- 2C Recorded Warranty Deed and/or Recorded Long-Term Lease and Buyers Settlement Statement.
- 3C Ownership Entity's Title Opinion or Title Guaranty Certificate.
- 4C Documentation of Proper Zoning.
- 5C Current documentation from the <u>HUD website</u> that substantiates the entire project is located in an eligible QCT or DDA.
- 6C Current applicable PHA, HUD, RD, or HUSM Model Utility Allowance documentation with the correct utility amounts circled. If using the HUSM model, a summary sheet for each bedroom size along with supporting documents including electric and gas tariffs sheets is required. Projects with HOME funding are required to use the HUSM model. HUD HUSM Model
- 7C Current Ownership Entity Organizational Chart.
- 8C Current Partnership Documents, including <u>ALL</u> attachments and Development Agreement, if applicable.
- 9C** Requirements of Enforceable Financing, closing/loan documents, filed mortgages, etc.
- 10C** Requirements of Pre-Paid Materials Documentation, if applicable.
- 11C* Independent Auditor's Report. IFA Form Required.
- 12C* Exhibit A to Independent Auditor's Report. IFA Form Required.
- 13C* Owner's Attorney Opinion. IFA Form Required.
- 14C* Certificate to Ownership and Basis. IFA Form Required.

IF AWARDED UNDER THE SUPPORTIVE HOUSING FOR FAMILIES SET-ASIDE:

16C** Fully executed written agreement between the Owner, Property Manager and the IFA-approved Qualified Service Provider.

<u>Construction Monitoring Fee:</u> The Construction monitoring fee is to be paid thru the online Application at the submission of the Carryover-10% Test Application.
