

Introduction to 2018 HOME Income Limits

On May 15, 2018, The United States Department of Housing and Urban Development (HUD) released the FY 2018 Income Limits for the HOME Investment Partnerships Program (HOME) program. **The updated limits are effective as of June 1, 2018.**

As an example of how to reach the charts provided by HUD, below are the income limits for Ames.

- ❖ The 2nd line, “Very Low Income,” refers to the 50% income limits associated with the LOW HOME Unit designation
- ❖ The 4th line, “Low Income,” refers to the 80% income limits associated with the HIGH HOME unit designation.
- ❖ The other two lines do not apply to HOME projects in Iowa.
