Good Afternoon,

We've been working through the Applicant Timeline for distribution this week. As we have been inserting dates into the schedule, we are seeing the need to respectfully ask if it would be possible for the CoC Committee to meet sometime the week of July 15th (we are suggesting the 16th) to take action on approval of the scores and ranking of renewal projects and approve the new project application. This way all information can be readily available for the full Council if needed on the 19th and we will be able to move the entire application process forward in a much more timely manner and prevents the schedule to be so tight later in August and September. If we have to wait until July 23rd – the previously agreed upon next meeting of the CoC Committee, the schedule becomes much more cumbersome, both for the applicants and for us.
